School Discipline Practices

Katella High School students have the opportunity to participate in a wide variety of activities including: Alcohol Awareness, Asset Building Strategies, Character Counts!, Children of Alcoholics, College Outreach, Conflict Resolution, Friday Night Live, Gang Awareness, Great American Smokeout, HS TUPE grant, Multicultural classes, National Inhalant Week, Positive After School Activities, Project SAY, Red Ribbon Week, Safe/Sober Graduation, Safe Training, School Safety grant, SMART team, Social Worker Intern program, SST, Yellow Ribbon Week. Katella is in the process of implementing the Ready To Learn Program and LINK CREW. Ready to Learn provides intervention counseling to prevent students from falling behind in the curriculum and becoming alienated from the social environment of the school, and LINK CREW orients ninth graders to the high school environment.

III. School Facilities

School Facility Conditions and Improvements

This section provides information about the condition of the school's grounds, buildings, and restrooms, and a description of any planned or recently completed facility improvements.

Katella High School opened in 1966. The 39.1 acre site includes 60 regular classrooms plus a number of portable classrooms. There are 26 labs which are designed for specific programs (i.e. computer lab, science lab, choral music room, etc.) The site also includes an auditorium, a cafeteria, a media center, two gyms and a pool facility, and a variety of sports fields.

Maintenance and Repair: Site and District maintenance staff ensure that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service. Emergency repairs are given the highest priority.

Cleaning Process and Schedule: The district board has adopted cleaning standards for all schools. The administration works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school. All classrooms and restrooms are cleaned daily and deep cleaning, waxing of floors, and painting takes place during times when students are not in classes. Students, parents and staff are encouraged to report any objectionable conditions via a uniform complaint procedure.

Katella High School is undergoing a large modernization and construction project with an estimated total budget of \$39.6 million. The estimated completion date for new construction is October, 2006 with final occupancy anticipated following the winter break, 2007. The estimated completion date for modernization is September, 2007 with final occupancy anticipated following winter break, 2008. Work on the newly constructed buildings is over 50 percent complete and includes the addition of 33 classrooms, administration facilities, a practice gym and student and staff parking. Because work on newly constructed buildings is currently underway, the renovation and modernization of existing facilities will proceed as originally planned. This is being done because any modification of the work would require resubmission of plans to the Division of the State Architect, which would cause additional delays.

Teachers are expected to leave detailed lesson plans for substituting teachers, and substitutes are required to leave information regarding the day and the progress made on the lesson plan.

XI. Instructional Planning and Scheduling

School Instruction and Leadership

All students are placed in the best possible learning situation within the resources of the district. To accomplish this, instruction at each grade level is based on the Board adopted grade level standards. These district content and performance standards reflect the state guidelines in each content area. Instruction is also to accommodate the varying interests and growth patterns of individual students and include strategies for addressing academic deficiencies when needed. Students shall progress through the grade levels by demonstrating growth in learning and meeting grade-level standards and benchmarks of expected learning achievement. It is the role of the site administrator to monitor instruction and student academic achievement. At Katella High School the current administrative team of one principal and three assistant principals work very hard at this responsibility. Their performance is evaluated annually by district administrative staff.

Professional Development

This section provides information about the program for training the school's teachers and other professional staff.

Teachers participate in a variety of District in-services as well as professional development workshops and conferences to enhance their knowledge and instructional skills. The Beginning Teacher Support and Assessment (BTSA) program, district workshops, and professional conferences are opportunities for professional development. The District continues to train teachers in strategies to deliver a differentiated curriculum with depth and complexity. Teachers learn to utilize student assessment results in order to target instruction to better meet the individual needs of students. Classified staff members have many opportunities to participate in training designed to enhance their effectiveness with students. All district staff members are supported in their efforts to be considered highly qualified under NCLB. Additionally, Katella provides support and training in the common assessment process, Professional Learning Communities, and AVID methodologies.
